ORDER DIRECTING ISS JANCE OF TAX DEED

THIS MATTER COMING on to be heard upon the verified Petition of The Nature Conservancy, for an Order on said Petition that a Tax Deed issue and upon proofs and exhibits heard and offered in open court, and the Court having heard the statements and arguments of counsel and having been fully advised in the premises, FINDS:

- 1. That it has jurisdiction of the subject matter hereof and of all of the parties hereto.
- 2. That the Tax Sale Notice, a copy of which is attached to and made a part of the said Petition filed herein, was served in the manner and within the time required by §§22-10 through 22-30 of the Property Tax Code, upon the persons entitled to such notice.
- 3. That all persons entitled thereto have had due notice of the filing and the time of hearing upon this Petition herein.

- 4. That the real estate hereinafter described has not been redeemed from the sales of December 21, 2007, pursuant to the judgment for sale as provided by the Property Tax Code (35 ILCS 200/1 et. seq.), and that the time for such redemption has expired on July 6, 2009.
- 5. That all general taxes and special assessments which have become due and payable subsequent to said sales have been paid, and all forfeitures and sales which occurred subsequent thereto have been redeemed.
- 6. That 21 of the material allegations of said Petition are true; that Petitioner has fully complied with all of the statutes and the Constitution of the State of Illinois relating to sales of real estate for taxes and the issuance of tax deeds pursuant thereto and is, therefore, entitled to a deed of conveyance vesting in Petitioner the title in fee simple to the hereinafter described real estate and every part thereof.

IT IS THEREFORE ORDERED that DAVID D. ORR, County Clerk of said Cook County, do forthwith make, execute and deliver to said Petitioner upon the surrender to said County Clerk of the Certificates of Purchase delivered to the original purchaser, a good and sufficient deed conveying to said Petitioner all of the following real estate to wit:

That part of vacated Mozart Avenue lying South of a line drawn from the Northeast corner of Lot 40 in Block 13 to the Northwest corner of

Lot 1 in Block 15 and lying North of a line drawn from the Southeast corner of Lot 36 in said Block 13 to the Southwest corner of Lot 5 in said Block 15, all in Croissant Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indian Boundary Line, in Cook County, Illinois

PARCEL 2B:

That part of vacated Francisco Avenue lying South of a line drawn from the Northeast corner of Lot 40 in Block 11 to the Northwest corner of Lot 1 in Block 13 and lying North of a line drawn from the Southeast corner of Lot 36 in said Block 11 to the Southwest corner of Lot 5 in said Block 13, all in Croissant Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indian Boundary Line, in Cook County, Illinois

PARCEL 2C:

That part of the 20 foot wide vacated alley lying South of a line drawn from the Northeast corner of Lot 1 in Block 11 to the Northwest corner of Lot 40 in said Block 11 and lying North of a line drawn from the Southeast corner of Lot 5 in said Block 11 to the Southwest corner of Lot 36 in said Block 11, all in Croissari, Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indian Boundary Line, in Cook County, Illinois

PARCEL 2D:

That part of the 20 foot wide vacated alley lying South of a line Grawn from the Northeast corner of Lot 1 in Block 13 to the Northwest corner of Lot 40 in said Block 13 and lying North of a line drawn from the Southeast corner of Lot 5 in said Block 13 to the Southwest corner of Lot 36 in said Block 13, all in Croissant Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indian Boundary Line, in Cook County, Illinois

PARCEL 2E:

The West 1/2 of the 20 foot wide vacated alley lying East of and adjacent to Lots 1 through 5 in Block 15 and the East 1/2 of said 20

foot vacated alley lying South of the North line of Lot 44 extended West and lying North of the South line of Lot 38 in said Block 15 extended West, all in Croissant Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indian Boundary Line, in Cook County, Illinois

PARCEL 2F:

The South 1/2 of vacated 157th Street lying North of and adjoining the North line of Lots 1 and 40 Block 11, Lots 1 and 40 Block 13 and Lots 1 and 44 Block 15 and said North line of said lots extended across alleys in said Blocks and extended across Francisco Avenue and Mozart Avenue lying East of the West line of Lot 1 Block 11 extended North and West of the East line of Lot 44 Block 15 extended North, all in Croissant Park Markham 8th Addition, being a Subdivision of the South 1/2 of the Southwest 1/4 of Section 13, Township 36 North, Range 13 East of the Third Principal Meridian, lying South of the Indiana Boundary Line, in Cook County, Illinois

In accordance with the Order entered in this cause on August 18, 2009, THE COURT PREVIOUSLY FOUND that there was no delivery or acceptance by the City of Markham of Trustee's Deed document number 0918757558, and that therefore, the City of Markham has no legal interest in the subject property pursuant to said Trustee's Deed;

THE COURT FINDS that the tax deed title of Petitioner will be free of any claim or interest of the City of Markham arising by virtue of Trustee's Deed document number 091875/558, provided a tax deed has been issued and timely recorded within the time limitations set for in Section 22-85 of the Property Tax Code (35 ILCS 200/22-85);

Pursuant to Section 22-40 of the Property Tax Code (35 ILCS 200/22-40), IT IS FURTHER ORDERED AND DECLARED that the following in rem real estate taxes will be merged into the tax deed title of Petitioner, provided a tax deed has been issued and timely recorded within the time limitations set for in Section 22-85 of the Property Tax Code (35 ILCS 200/22-85):
