On April 29, 2008, Claimant proposed to perform certain work for Owner and on or about May 9, 2008, Owner by and through its agent accepted said proposal ("Contract"), under which Claimant agreed to provide all material and labor for the construction of improvements on the Real Estate including but not limited to tile and new sub-floor installation to various levels of the property; prepare walls and install stone and crown molding; install stairs, membrane to all shower bases and pour concrete; install new Ditra membrane to floors, electric heat floors, tile shower floors, and tile tub splash; frame niches to the bathroom; and install fireplaces and kitchen hood for the original contract amount of \$37,500.00.
