MODIFICATION AND EXTENSION AGREEMENT

WHEREAS, the parties hereto wish to modify the terms of sain Note and Mortgage by decreasing the interest rate and recalculating the monthly principal and into est payment based upon a 7 year amortization and as otherwise set forth herein;

NOW THEREFORE, in consideration of ONE DOLLAR (\$1.00), the cover ants herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 4. The new monthly payment will be in monthly installments of principal and interest in the amount of One Thousand Three Hundred Twenty Seven and 60/100 Dollars (\$1,327.60) each beginning August 1, 2009 and continuing on the 1st day of each and every month
