This Claim for and Notice of Lien is brought pursuant to the Bridgeview Village Code, Sections 9-2-1, 9-2-2 and 9-2-3 of Article II (Health Regulations), which empower Claimant to enter upon the Property for the abatement of a nuisance and to place a lien upon the Property for all costs incurred in abating such nuisance and in preparing, filing, recording and releasing such lien.

2. Pursuant to Section 9-2-4, a lien filed under such Article II of the Health Regulations shall bear interest at the rate of 1% per month or any portion thereof.

3. On August 18, 2009 and September 4, 1009, the Village did enter upon the Property for the purpose of weed and/or vegetation removal, incurring the following costs:


4. That Claimant has incurred or shall incur the following costs and fees with respect to this lien:





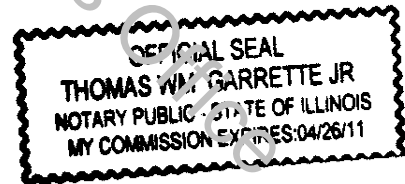
