MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated November 5, 2008, is made and executed between Standard Bank and Trust Company, not personally but as Trustee on behalf of Trust #18506, whose address is 7800 West 95th Street, Hickory Hills, IL 60457 (referred to below as "Grantor") and Standard Bank and Trust Company, whose address is 7800 West 95th Street, Hickory Hills, IL 60457 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated November 22, 2006 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property located in Cook County, State of Illinois:

A part of Lot 25 in Oak Lawn Farms, being a Subdivision of the Southwest 1/4 of Section 5, Township 37 North, Range 13, East of the Third Principal Meridian, (except the East 1/2 of the East 1/2 of the Southeast 1/4 of said Southwest 1/4) which part of Lot 25 bounded and described as follows: Beginning on the East line of the West 1/2 of that part of said Lot 25 which lies West of the East 33 feet and North of the South 401 feet measured perpendicularly thereof, a point which is 33 feet South from the North line of said Lot 25; Running thence South along the East line of the West 1/2 aforesaid, a distance of 193.86 feet to its intersection with the North line of the South 401 feet measured perpendicularly of said Lot 25; Thence West along the North line of the South 401 feet aforesaid a distance of 151.07 feet to its intersection with the West line of said Lot 25; Thence North along said West line of Lot 25 a distance of 193.73 feet to its intersection with the South line of the North 33 feet of said Lot 25; Thence East along the South line of the North 33 feet of said Lot 25; Thence East along the South line of the North 33 feet aforesaid a distance of 151.10 feet to the point of beginning in Cook County, Illinois.

The Real Property or its address is commonly known as 6115 West 94th Street, Oak Lawn, IL 60453. The Real Property tax identification number is 24-05-303-065.

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The interest rate is increased to rate equal to the Prime Rate of Lender as it changes from time-to-time plus 2.0%. Minimum interest rate is increased to 7.0%. The Maturity Date is extended to February 5, 2009 and the Repayment is modified as more fully set out in a Change in Terms Agreement of the same date herewith incorporated herein by this reference.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.


