
SUBORDINATION AGREEMENT





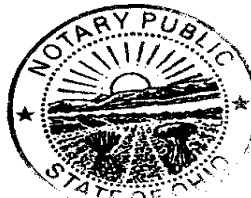
