- 3. That "Westward" entered into an oral contract with "Illinois Brick", whereby Claimant agreed to furnish "Westward" with brick and stone in exchange for payment in the original Contract amount of Eighty-Seven Thousand, Fifty-Five Dollars & 80/100, (\$87,055.80).
- 4. The Subcontract was entered into between "Westward" and "Illinois Brick" with the full knowledge and consent of the Owner(s). Alternatively, the Owner(s) specifically authorized "Westward" to enter into Contracts for intercovernment of the Real Estate. Alternatively, the Owner(s) knowingly permitted "Westward" to enter into Contracts for, and in said improvement of the Real estate.
- 5. At the special instance and request of "Westward" and with the full knowledge and express consent or acquiescence of Owners, Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$ .00. Claimant completed providing the additional materials and labor at various times.
- 6. That on July 31, 2009 Claimant completed and delivered, substantially all work and materials required to be performed under the Subcontract.
  - 7. That "Westward" is entitled to credits for payments in the amount of \$75,007.01.
