MODIFICATION & EXTENTION AGREEMENT

WHEREAS, it is agreed by said party of the second part that there is now due and owing on said note a Line of Credit in the amount of Nikety Three Thousand 00/100 Dollars (\$93,000.00) with an unpaid principal balance of Ninety Three Thousand and 00/100 Dollars (\$93,000.00) and the principal amount remains unchanged.

WHEREAS, the party of the second part desires an extension of time of payment of said note, and the party of the first part has agreed to such an extension of time of payment.

The agreement shall be binding upon the successors or assigns of the party of the first part and the neirs, executors, administrators and assigns of the party of the second part.
