## MEMORANDUM OF JUDGMENT

On November 11, 2009, judgment was entered in favor of the plaintiff, VILLAGE OF ARLINGTON HEIGHTS, 33 S. Arlington Heights Road, Arlington Heights, IL 60005, and against defendant, Chicagoland Builders, Inc et al., and the property commonly known as 1501 W. Palatine Rd., Arlington Heights, IL 60005, and legally described as:

The West half of the West 267.71 feet of the East 309.21 feet of the North 659.62 feet of the East half of the West half of the Northwest quarter of Section 19, Township 42 North, Range 11, East of the Third Principal Meridian, excepting there from that part used for road or highway purposes, in Cook County, Illinois, excepting from the above described tract of land taken as a whole, that portion lying Northerly and Westerly of the following described line: Commencing at a point on the West line of said tract that is 366.62 feet North of the Southwest corner of said tract; thence Northeasterly to a point on a perpendicular line drawn through the aforesaid West line 463.62 feet North of the Southwest corner of said tract, said point on the perpendicular line being 32 feet East of the aforesaid West line; thence Northeasterly to a point on a perpendicular line drawn through the East line of said tract 511.62 feet North of the Southeast corner of said tract, said point on the perpendicular line being 73 feet West of the said East line; thence Northeasterly to a point on the East line of said tract that is 524.56 feet North of the Southeast corner of said tract; all in Wheeling Township, Cook County, Illinois; and also, together with: All that part of the East 297.16 feet of the North 659.62 feet of the West 10 acres of the North half of the East half of the West half of the Northwest quarter of Section 19, lying Southeasterly of the Southeasterly right-of-way line of the


