TERMINATION OF LEASE AGREEMENT

THIS AGREEMENT is made this 9th day of July, 2009, by and between the METROPOLITAN WATER RECLAMATION DISTRICT OF GREATER CHICAGO, a municipal corporation organized and existing under the laws of the State of Illinois, with principal offices at 100 East Erie Street in Chicago, Illinois 60611 (hereinafter "Lessor"), and the VILLAGE OF LINCOLNWOOD, a body corporate and politic organized and existing under the laws of the State of Illinois, with principal offices at 6900 North Lincoln Avenue, Lincolnwood, Illinois 60712 (hereinafter "Lessee").

WITNESSETH

WHEREAS, the Lesson and Lessee entered into a Lease Agreement dated August 3, 1989 (the "Old Lease Agreement"), pursuant to which the Lessor leased to Lessee 17.30 acres of land commonly known as the Channel Runne Park, located along the west side of the North Shore Channel between Devon Avenue and Touhy Avenue in the Village of Lincolnwood, Cook County, Illinois and legally described on Exhibit A attached hereto (the "Leasehold Premises"), for the period commencing September 1, 1989, and ending August 31, 2014; and

WHEREAS, the Lessee desires to simultaneously (i) surrender and terminate the Old Lease Agreement as of November 1, 2009, and (ii) er:ter into a new 39-year lease for the Leasehold Premises also as of November 1, 2009 (the "New Lease Agreement"); and

WHEREAS, at its meeting on July 9, 2009, the Lessor's Board of Commissioners authorized (i) the early surrender and termination of the Old Lease Agreement, and (ii) issuance of the New Lease Agreement;

NOW THEREFORE, for and in consideration of TEN AND NO/100 DOLLARS (\$10.00) in hand paid by Lessee to the Lessor and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Lessor and Lessee hereby agree as follows:

- 1. The Old Lease Agreement is hereby surrendered and terminated as of November 1, 2009.
- 2. Simultaneous with surrender and termination of the Old Lease Agreement, the Lessor and Lessee will enter into the New Lease Agreement to allow the Lessee continued use and occupancy of the Leasehold Premises throughout the 39-year term of the New Lease Agreement.
