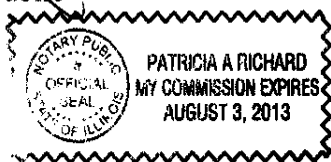

That part of Lot 6 in Circuit Court Partition of the Northeast quarter of Section 32, and the West half of the Northwest quarter of Section 33, Township 35 North, Range 14, East of the Third Principal Meridian, commencing at the Northeast corner of Lot 6 at the intersection of the Southerly line of the Sauk Trail Road with the Westerly line of the Chicago and Vincennes Road thence Westerly along the South line of the Sauk Trail Road 150 feet thence Southerly parallel with the Chicago and Vincennes Road 150 feet Easterly parallel with the Sauk Trail Road 150 feet thence Northerly along the Westerly line of the Chicago and Vincennes Road to the place of beginning, (excepting therefrom that part thereof described as follows:
