FIRST AMENDMENT TO THE DECLARATION OF CONDOMINUM OWNERSHIP FOR THE WOOD WINDS CONDOMINIUMS

THIS FIRST AMENDMENT (the "First Amendment") to the Declaration of Condominium Ownership for the Wood Winds Condominiums (the Declaration") is made and entered in this 26th day of October, 2009, is executed by the Board of Managers of the Wood 'Winds Condominium Association (the "Board") and is approved by at least three-fourths (3/4) of the unit owners of the Wood Winds Condominium Association (the "Association") as evidenced by the attached signature pages.

WITNESSETH:

WHEREAS, by a DECLARATION OF CONDOMIUM OWNERSHIP FOR THE WOOD WINDS CONDOMINIUMS recorded on March 6, 1996 in the Office of the Recorder of Deeds for Cook County, Illinois as Document Number 96169181 submitting certain real estate to the provisions of the Illinois Condominium Property Act, the legal description and the Permanent Index Numbers of which real estate (the "Property") are set forth in Exhibit A to this First Amendment.

WHEREAS, the Board of the Association and certain unit owners deem it now to be in the best interests of the Association to amend the Declaration to eliminate any right of first refusa, found in the Declaration.

WHEREAS, under Article XIII, Paragraph A (2) of the Declaration, the Declaration may be amended by an instrument in writing setting forth such amendment, signed and acknowledged by all of the members of the Board and at least three-fourths (3/4) of the unit owners and containing an affidavit of an officer of the Board certifying the a copy of the amendment has been mailed by certified mail to all mortgagees having bona fide liens of record against any unit, not less than ten (10) days prior to the date of such affidavit;

WHEREAS, this First Amendment has been approved by at least three-fourths (3/4) or the unit owners and by all members of the Board, as evidenced by the attached signature pages.

WHEREAS, a copy of this First Amendment has been mailed by certified mail to all mortgagees having bona fide liens of record against any unit, not less than ten (10) days prior to the date of the Affidavit attached to this First Amendment.

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. Article VIII, of the Declaration is amended to delete all reference to the Board and/or the Association having a right of first refusal. This shall not affect the obligation of the unit owner to give notice to the Board and/or Association of any sale or lease.
