2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Borrower shall promptly discharge any lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the proment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is perferring such agreement; (b) contests the lieu in good faith by, or defends against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending. 5. Property Insurance. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding percentage points (Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one TWO AND 250/1000 percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrow, "'s interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.
