
lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified, at any time or times hereafter.

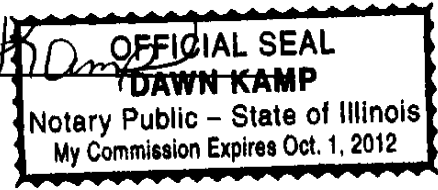

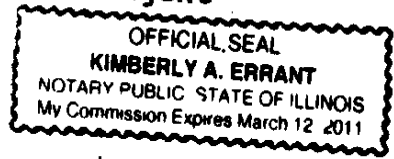

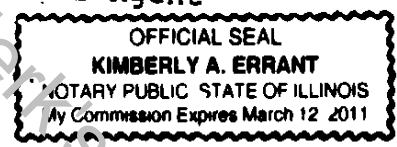
