Whether or not Borro ver is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from tetriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that requir or restoration is not economically feasible, Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. If insurance or condemnation proceeds are paid in connection with damage to, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repair, and restoration in a single payment or in a series of progress payments as the work is completed. If the 1 id:x is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding percentage points TWO AND ONE QUARTER % to the Current Index. The Note Holder will then round the result 2.250 of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the

The Note Holder will then determine the amount of the monthly payment that would be next Change Date. sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes
