The Parties and the Property at Issue

- 2. The City is a municipal corporation organized and existing under the laws of the State of Illinois.
- 3. Within the corporate limits of Chicago, there is a parcel of real estate legally described as:

LOTS 16, 17, 18, 19, AND THAT PART OF LOT 20 DESCRIBED AS LYING WEST OF A LINE RUNNING THOUGH THE CENTER 12 ½ INCH BRICK WALL, THAT IS 4.62 FEET EAST OF THE SOUTHWES?
