The Additional Property described in Exhibit A-4 attached hereto is hereby annexed to the Condominium Property (as defined in the Declaration) and is hereby submitted to the provisions of the Act as a part of the Condominium in accordance with, and deemed to be governed in all respects by, the terms and provisions of the Declaration.



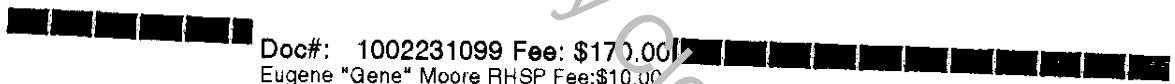
