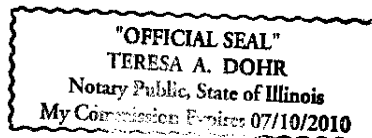

The authority herein shall include such incidental acts as are reasonably required to carry out and perform the specific authorities granted herein.

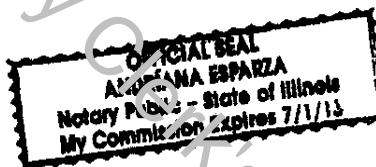
