MEMORANDUM OF FIRST AMENDMENT TO SITE LEASE ACKNOWLEDGEMENT

THIS MEMORANDUM OF FIRST AMENDMENT TO SITE LEASE ACKNOWLEDGEMENT ("Amended Memorandum"), by and between Emergency Service, Inc., an Indiana corporation ("Lessor") and SprintCom, Inc., a Kansas corporation ("Lessee"), evidences that the lease made and entered into by written instrument between Lessor and Lessee or Lessee's affiliate, dated November 14, 1997 ("Agreement"), has been amended by written instrument between the parties (the "An endment"). 
