Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. - 8. Borrower's Lean Application. shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. 14. Loan Charges. jurisdiction where the Property is located that relate to health, safety or environmental protection; (c) "Environmental Cleanup" includes any response action, remedial action, or removal action, as defined in Environmental Law; and (d) an "Environmental Condition" means a condition that can cause, contribute to, or otherwise trigger an Environmental Cleanup.





#### (C) Payment Change Dates

My monthly payment may change as required by Section 3(D) below beginning on the 1st day of January, 2007, and on that day every 12th month thereafter. Each of these dates is called a "Payment Change Date." My monthly payment will also change at any time Section 3(F) or 3(G) below requires me to pay the Full Payment.
