- 3. That "Spuria" entered into an oral Contract with M. Randazzo Landscaping, Inc., ("Randazzo") whereby Claimant agreed to furnish Landscaping and Sprinkler System Installation (related materials, apparatus, and labor) to "Spuria" in exchange for payment in the Original Contract amount of Thirteen Thousand, Eight Fundred and Eighty-Five Dollars & 00/100, (\$13,885.00).
- 4. That the Contract was entered into between "Spuria" and Claimant with the full knowledge and consent of Owner. Alternatively, the Owner specifically authorized "Spuria" to enter into Contracts for, and in said improvement of the Real Estate. Alternatively the Owner did knowingly permit "Spuria" to enter into Contracts, for and in said improvement of the Real Estate.
- 5. At the special instance and request of "Spuria" and with the full knowledge and express consent or acquiescence of Owner, Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$1,100.00. Ciaimant completed providing the additional materials and labor at various times.
- 6. That on October 28, 2009, Claimant completed and delivered substantially all work and materials required to be performed under the Contract.
 - 7. That "Spuria" is entitled to credits for payments in the amount of \$5,000.00.
- 8. As of the date hereof, there is due, unpaid and owing to Claim int, after allowing credits for payments by "Spuria" the balance of Nine Thousand, Nine-Hundred and Eighty-Five Dollars & 00/100, (\$9,985.00), for which with interest at the statutory rate of 10% per annum, Claim of claims a lien on the Real Estate and on the monies or other considerations due, or to become due from the Owner to Spuria Construction, Inc.
