Beginning at the Northeast corner of said Lot 1; thence South 02 degrees 24 minutes 15 seconds East, along the East line of said Lot 1, a distance of 131.99 feet to the Southeast corner of said Lot 1; thence South 87 degrees 51 minutes 27 seconds West, along the South line of said Lot 1, a distance of 10.00 feet; thence North 02 degrees 24 minutes 15 seconds West a distance of 69.91 feet; thence North 49 degrees 07 minutes 28 seconds West a distance of 56.54 feet; thence South 87 degrees 51 minutes 28 seconds West a distance of 80.73 feet to the West line of said Lot 2; thence North 02 degrees 24 minutes 15 seconds West, along the West line of said Lot 2, a distance of 23.50 feet to the North line of said Lot 2; thence North 87 degrees 51 minutes 28 seconds East, along the North line of said Lot 2, a distance of 131.90 feet to the point of beginning.
