



### **EXHIBIT B**

### PERMITTED EXCEPTIONS

- 1. General real estate taxes not yet due and payable.
- 2. Encroachment of the building located mainly on Parcel 4, onto public property north and adjoining by .17 feet and east and adjoining, at the southeast corner, by .09 feet.
- 3. Encreashment of the building located mainly on Parcel 2, onto public property north and adjoining by .17 feet.
- 4. Encroachment of the building located mainly on Parcel 2, onto property southwesterly and adjoining by .31 to 59 feet.
- 5. Encroachment of the bulding located mainly on Parcel 3, onto property southwesterly and adjoining by .05 feet.
- 6. Encroachment of the building located on Parcel 1 over the Commonwealth Edison Company easement recorded as document 15745668.
- 7. Encroachment of concrete ramps located mainly on Parcel 3, onto the public alley lying east and adjoining by 17.08 feet.
- 8. Encroachment of the chain link fence east of and adjoining Parcel 3, onto the public alley by 12.5 feet.
- 9. Ecroachment of the retaining wall located mainly on Parcel 3, onto public property northeasterly and adjoining by .17 feet and onto property southeasterly and adjoining by .26 feet.
- 10. Easement in favor of Commonwealth Edison Company, and its/their respective successors and assigns, to install, operate and maintain all equipment necessary for the purpose of serving the land and other property, together with the right of access to said equipment, and the provisions relating thereto contained in the grant recorded October 16, 1953 as document 15745868 and filed August 2, 1954 as document LR1538560 as follows:

Over that part of the east and west and northwesterly and southeasterly public alleys lying south of and adjoining Lots 9 to 11 both inclusive and the south line of said lots extended west; east of the west line of said Lot 11 extended south; west of the east line of said Lot 9 extended south all in Block 30 and lying north of and adjoining Lot 65 and the north line of said Lot 65 extended west in Oviatt's subdivision aforesaid.
