SUBORDINATION OF LIEN

WITNESSETH

WHEREAS, Imad I. 

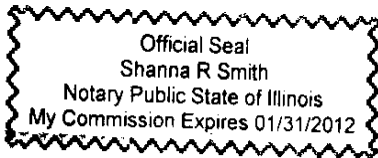
