

3. Notice was published in the Chicago Sun-Times in Chicago, Illinois, from July 30, 2009 through August 2, 2009



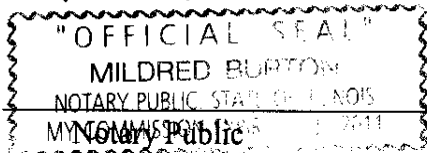
