Subsequently, pursuant to the special instance and request of Owner, Claimant provided extra labor to the Project in the total amount of *Four Hundred Thirty Thousand Four Hundred Dollars* (\$430,400.00), thereby resulting in an adjusted contract sum of *Five Hundred Thirty Thousand Four Hundred Dollars* (\$530,400.00).

On November 18, 2009, Claimant completed all that was required to be done by said Contract.

That as of the date hereof, Owner is entitled to credits in the amount of *One Hundred Seventy-Nine Thousand Seven Hundred Fifty Dollars (\$179,750.00)*, leaving due and owing to Claimant the sum
