MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 16, 2010, is made and executed between Ana Tapia, divorced never since remarried, whose address is 1414 N. Western Ave., Chicago, IL 60622 (referred to below as "Grantor") and Pacific Global Bank, whose address is 2323 S. Wentworth Ave., Chicago, IL 60616 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated March 12, 2007 (the "Mortgage") which has been recorded in Knox County, State of Illinois, as follows:

THAT PART OF LOTS 3 AND 10 IN THE SUBDIVISION OF THE NORTHEAST QUARTER OF SECTION 32, IN TOWNSHIP 11 NORTH, RANGE 2 EAST OF THE FOURTH PRINCIPAL MERIDIAN, KNOX COUNTY, ILLINOIS; WHICH CONTAINS APPROXIMATELY 1.30 ACRES AND WHICH IS DESIGNATED AS TRACT "A" ON THE PLAT OF SURVEY DATED MAY 14, 1974, BY MELVIN G. CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
