- 10. Reinstatement. Borrower has a right to be reinstated if Lender has required immediate payment in full because of Borrower's failure to pay an amount due under the Note or this Security Instrument. This right applies even after foreclosure proceedings are instituted. - 15. Borrower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.
