MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated July 12, 2008, is made and executed between **HAIM GABI and DALIA GABI, AS HUSBAND AND WIFE** (referred to below as "Grantor") and **1st Equity Bank**, whose address is 3956 West Dempster St, Skokie, IL 60076 (referred to below as "Lender").



This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



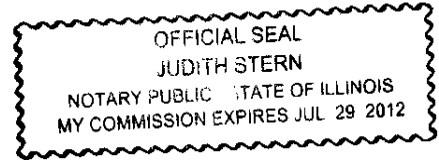

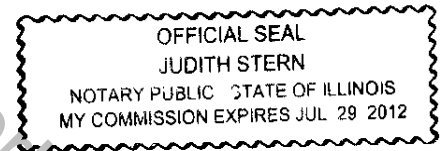
