After prorating the principal sum of \$44,390.00 owed for Contractor's work by fifty percent (50%) pursuant to the percentage interest of common area attributable to Unit 2 under the provisions of the 2835 West Wellington Condominium Declaration, Claimant claims a lien on the Premises and improvements in the sum of \$22,195.00
