- 3. That plaintiffs, Winifred Jordan and Keith Jordan, are the owners in fee simple of certain real estate situated in Cook County, Illinois, and described in the Complaint, to wit:

- 4. Cozzy Home Creation and Unknown Owners unlawfully claim the title to and some interest or right in or to said premises by virtue of a certain deed purportedly executed and delivered by Winifred Jordan on May 7, 2008, and recorded in the office of the Recorder of Deeds in Cook County, Illinois, on May 9, 2008, as document No. 08 13 010 295.
- 5. That said deed, while it appears to be valid, is actually invalid for the reason that it is a forgery and was not signed by Winifred Jordan and was without consideration or the consent of Winifred Jordan.
- 6. That the claim of Cozzy Home Creation and Unknown Owners under said deed constitutes a cloud on the title of plaintiffs to said real estate, which greatly diminishes the value and interferes with the sale thereof; and
 - 7. That the equities of this case are with plaintiffs.

WHEREFORE, IT IS ORDERED, DECREED AND ADJUDGED BY THE COURT AS FOLLOWS:

1. That said claim of Cozzy Home Creation and Unknown Owners be and it is hereby declared to be illegal and void, and that Eugene Moore, the Cook County Recorder of Deeds, or his successor, be and is hereby authorized and directed to cancel said deed of record.
