THIRD AMENDMENT TO MORTGAGE, SECURITY AGREEMENT AND FIXTURE FILING

THIS THIRD AMENDMENT TO MORTGAGE, SECURITY AGREEMENT AND FIXTURE FILING (this "Third Amendment") is made and entered into as of March 5, 2010 by THOR PALMER HOUSE HOTEL & SHOPS LLC, a Delaware limited liability company, having an office at c/o Thor Equities, Inc., 25 West 39th Street, New York, New York 10018 ("Borrower"), and THOR PALMER HOUSE HOTEL LLC, a Delaware limited liability company, having an office at c/o Thor Equities, Inc., 35 West 39th Street, New York, New York 10018 ("Hotel Lessee"; Borrower and Hotel Lessee are referred to herein collectively as "Mortgagor") to ANGLO IRISH BANK CORPORATION LIMITED (f/k/a Anglo Irish Bank Corporation plc), a limited company organized under the laws of the Republic of Ireland having its principal place of business at 18/21 St. Stephen's Green, Dublin 2, Ireland, and an address at 222 East 41st Street, 24th Floor, New York, New York 10017, as Administrative Agent for the Lenders referred to below (together with its successors and assigns, hereinafter referred to as "Mortgagee") and pertains to the property described on Schedule A attached hereto.

WITNESSETH:

WHEREAS, Mortgagor and Mortgagee entered into that certain Loan Agreement dated as of December 11, 2006, as amended by that certain First Amendment to Loan Agreement dated February 7, 2007, Second Amendment to Loan Agreement dated as of February 29, 2008, and further amended by that certain Third Amendment to Loan Agreement dated as of March 26, 2008 (the "Original Loan Agreement") in connection with a loan (the "Original Loan") made by Mortgagee to Mortgagor in the original principal amount of \$307,700,000.00;

WHEREAS, the Original Loan was evidenced by that certain (i) Promissory Note A-1 dated as of February 7, 2007 made by Borrower in favor of CIBC Inc. in the original principal amount of \$50,000,000.00, Promissory Note A-2 dated as of February 7, 2007 made by Borrower in favor of CIBC Inc. and endorsed to Deutsche Hypothekenbank AG in the criginal principal amount of \$50,000,000.00, Promissory Note A-3 dated as of February 7, 2007 made by Borrower in favor of CIBC Inc. and endorsed to ING Real Estate Finance (USA) LLC in the original principal arrount of \$50,000,000.00 (collectively, the "A Notes") and Promissory Note B dated as of December 11, 2006 made by Borrower in favor of Anglo Irish Bank Corporation Limited f/k/a Anglo Irish Bank Corporation plc in the original principal amount of \$157,700,000.00 (the "B Note"), together with the A Notes, collectively, the "Original Note");

WHEREAS, the Note is secured by, *inter alia*, that certain Mortgage, Security Agreement and Fixture Filing dated December 11, 2006 and recorded in the Office of the Cook County Accorder of Deeds on December 12, 2006 as Instrument No. 0634644080, as amended by First Amenament to Mortgage, Security Agreement and Fixture Filing, dated February 29, 2008 and recorded in the Office of the Cook County Recorder of Deeds on March 4, 2008 as Instrument No. 0806403011 and as in ther amended by Second Amendment to Mortgage, Security Agreement and Fixture Filing, dated March 26, 2008 and recorded in the Office of the Cook County Recorder of Deeds on April 16, 2008 as Instrument No. 0810731063 (as amended, and as may be further amended, modified, supplemented or otherwise changed from time to time, the "Mortgage");

WHEREAS, the terms of the Original Loan are herewith being modified and, accordingly, the Original Loan Agreement has been amended and restated in its entirety by that certain Amended and Restated Loan Agreement dated as of the date hereof by and among Mortgagor, Mortgagee and Lenders (the "Loan Agreement");

WHEREAS, the Original Note and loan documents evidencing the Original Loan ("Original Loan Documents") have been modified by that certain Omnibus Loan Modification Agreement dated as of the date hereof;

NOW THEREFORE, in consideration of the premises, the mutual covenants contained herein, and the sum of Ten and No/100 Dollars (\$10.00), paid in hand by each party to the other, the receipt, adequacy and sufficiency of all of which are hereby acknowledged, the parties agree as follows:

- 1. <u>Definitions</u>. Capitalized terms that are not defined herein shall have the meanings ascribed to such terms in the Loan Agreement.
- 2. <u>Modification of Mortgage</u>. All terms used in the Mortgage and not therein defined shall have the meanings ascribed to such terms as set forth in the Loan Agreement.
- 3. <u>I gal Description</u>. The legal description which is attached to the Mortgage is hereby deleted in its entirety and substituted with that attached hereto as <u>Schedule A</u>. The lien of the Mortgage is hereby spread to cover the rights granted to Borrower pursuant to that certain Reciprocal Easement and Operating Agreement dated December 11, 2006 and recorded December 12, 2006 as document number 0634644078.
- 4. <u>Modification of Additional Terms of the Loan</u>. Certain additional terms of the Original Note and Original Loan Documents were amended in the Loan Agreement and Omnibus Modification, including, without limitation, the maturity date and the interest rate. The modifications are more particularly set forth in the Omnibus Modification and Loan Agreement.
- 5. <u>Reaffirmation; No Impairment.</u> Mo tgr.gor hereby reaffirms all of its obligations under the Mortgage. Except as specifically hereby amended, the Mortgage shall remain unaffected by this Third Amendment and shall remain in full force and effect. Notning in this Third Amendment shall impair the lien and security instrument of the Mortgage.
- 6. <u>Integration</u>. This Third Amendment and any attached consents or exhibits requiring signatures may be executed in counterparts, and all counterparts shall constitute but one and the same document. If any court of competent jurisdiction determines any provision of this Third Amendment or any of the other Loan Documents to be invalid, illegal or unenforceable, that portion shall be deemed severed from the rest, which shall remain in full force and effect as though the invalid, illegal or unenforceable portion had never been a part of the Loan Documents.
- 7. <u>Limitation on Liability</u>. The liability of Borrower is limited as and to the extent set forth in Section 10.1 of the Loan Agreement. The liability of Hotel Lessee is limited as and to the extent set forth in Section 19 of the Hotel Lessee Guaranty.
