
SUBORDINATION AGREEMENT

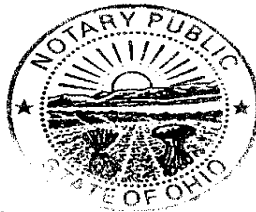
