 - 1. On July 21, 2009, the Village of Northfield passed and approved Ordinance No. 09-1424, "Establishing Special Service Area No.09-1, for Drury Lane Repairing in the Village of Northfield, Cook County, Illinois" (the "Ordinance"). A copy of the Ordinance is attached hereto as "Exhibit A".
 - 2. The Oldinance was recorded on February 4, 2010 in the records of the Cook County Recorder of Deeds as Document No. 1003544076.
 - 3. The Ordinance creates a Special Service Area to provide special municipal services to the area including paving of Drury Lane.
 - 4. A scrivener's error appears in "Exhibit A" of the Ordinance. The legal description contained in Paragraph 1 is incorrect and is hereby deleted and substituted therefore as follows:

AN ORDINANCE ESTABLISHING SPECIAL SERVICE AREA, NUMBER 09-1, FOR DRURY LANE REPAVING IN THE VILLAGE OF NORTHFIELD, COOK COUNTY, ILLINOIS

WHEREAS, special service areas are authorized pursuant to item (6) of Section 7 of Article VII of the 1970 Constitution, and are established pursuant to the provisions of the "Special Service Area Tax Law," 35 ILCS 200/27-5, et seg., as amended; and

WHEREAS, it is in the public interest that the area hereinafter described be established as Special Se vice Area Number 09-1 (the "Area"), for the purposes set forth herein; and

WHEREAS, the Area is compact and contiguous and is totally within the corporate limits of the Village of Northfield, Cook County, Illinois (the "Village"); and

WHEREAS, the residents in the Area have expressed a desire to have a private road, Drury Lane, east of Sunset Kiege, repayed by means of a Special Service Area; and

WHEREAS, the Area will benefit specially from the paving of the roadway to be provided (the "Services"), the Services are unique and in addition to municipal services provided to the Village as a whole and it is, to refore, in the best interests of the Village that the establishment of the Area be considered; and

WHEREAS, it is in the public interest that each house within the Area pay for the repaving of the road, with a total project cost up to \$250,000, which payment shall be paid either by a lump sum or through a semiannual assessment by the Village, amortized over 4 years at a rate of interest of 5% per year (the "Taxes"); and

WHEREAS, the establishment of the area proposed by the President and Board of Trustees (the "Village Board") pursuant to Ordinance No. 09-1415 exitled:

AN ORDINANCE PROPOSING THE ESTABLISHMENT OF SPECIAL SERVICE AREA NO. 09-1 IN THE VILLAGE OF NORTHFIELD, COOK COUNTY, ILLINOIS, AND PROVIDING FOR A PUBLIC HEARENG AND OTHER PROCEDURES IN CONNECTION THEREWITH

duly adopted on the 19 day of May, 2009, and was considered at a public hearing held on the 16 day of June, 2009, by the Village Board (the "Hearing"); and

WHEREAS, notice of the Hearing was given by publication in the Winnetka Talk, the same being a newspaper of general circulation within the Village; and

WHEREAS, mailed notice of the Hearing was given by depositing notice in the United States mails addressed to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within the Area not less than ten (10) days prior to the time set for the Hearing, and in the event taxes for the last preceding year were not paid, the notice was sent to the person last listed on the tax rolls prior to that year as the owner of said property; and

WHEREAS, the Hearing was held on the 16 day of June, 2009, and all interested persons affected by the establishment of the Area and the levy of the Taxes, including all persons owning taxable real property located within the Area, were given an opportunity to be heard at the Hearing regarding the establishment of the Area and the levy of the Taxes and an opportunity to file objections to the establishment of the Area and the levy of the Taxes; and

WHEREAS, at the Hearing, all interested persons affected by the Area were permitted to file with the Village Clerk of the Village written objections to and to be heard orally in respect to the issue embodied in the Notice of Hearing; and

WHEREAS, the Village Board has heard and considered all of the comments, and there were no objections and no protests that indicate that this Ordinance should not be passed in the judgment of he Village Board, and all statements made with regard to the Area and the Taxes were mostly ravorable and the Village Board has determined and does hereby determine that it is in the public interest and in the interest of the Village and the Area that the Area be established; and

WHEREAS, after hearing and considering all such comments and statements, the Village Board finds that it is in the public interest and in the interest of the Village of Northfield that Special Service Area Number 39-1, as hereinafter described, be established.

NOW, THEREFORE, BE !! ORDAINED by the President and Board of Trustees of the Village of Northfield, Cook County, I'mois, as follows:

SECTION 1. That the President and Poard of Trustees find that the recitals set forth above are true and correct and said recitals of this Ordinance are hereby incorporated into this text as the findings of the President and Board of Trustees as fully as if set out herein in their entirety.

SECTION 2. That the President and Board of Trustees nave found and determined the Public Hearing was held in accordance with the law.

SECTION 3. That Special Service Area Number 09-1 is hereby established in and for the Village and shall consist of the following described territory all vithin the Village of Northfield, Cook County, Illinois, which is described as shown on **Exhibit A**, attached hereto and made a part hereof.

The location of said territory is: all properties along private Drury Lane east of Sunset Ridge Road, in the Village of Northfield, Illinois.

The permanent index numbers for the Property are also shown on **Exhibit A.**

An accurate map of the Area attached hereto and made a part hereof as **Exhibit B.**

<u>SECTION 4</u>. That the purpose of the establishment of said Special Service Area Number 09-1 is, and said Special Service Area is so established, to provide for the resurfacing of Drury Lane, a private roadway, including but not limited to all engineering design, construction supervision, legal and other fees associated with the cost of the roadway resurfacing project.

SECTION 5. That a special tax shall be levied against the property included in the Area for the payment of the roadway resurfacing and associated expenses as set forth in Exhibit C, which shall be in addition to all other taxes permitted by law.

SECTION 6. That all ordinances, orders and resolutions and parts thereof in conflict herewith be and the same are hereby repealed, and that this Ordinance shall be in full force and effect from and after its adoption as required by law. The Village Clerk is hereby directed and ordered to file a certified copy of this Ordinance with the Cook County Recorder's Office, within sixty (60) days of the effective date hereof.
