## MODIFICATION OF MORTGAGE

**THIS MODIFICATION OF MORTGAGE** dated January 15, 2010, is made and executed between Scott D Meyer and Christen D Meyer (referred to below as "Grantor") and First National Bank of LaGrange, whose address is 620 W. Burlington Ave., La Grange, IL 60525 (referred to below as "Lender").



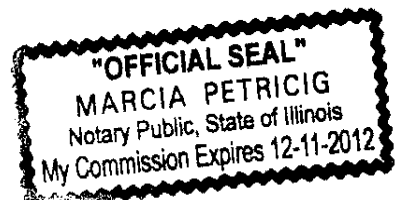
