SPECIAL WARRANTY DEED

Hoyne Ave., Apt. 1, Chicago, IL 60622 ("Grantee"), the receipt and sufficiency whereof is hereby acknowledged, by these presents does GRANT AND CONVEY unto Grantees, not as tenants in common but as joint tenants, and to their successors and assigns, FOREVER, all interest in and to the real estate situated in the County of Cook and State of Illinois, commonly known as 1610 W. Fullerton Ave., Units 501, P2 and P3, Chicago, IL 60614, and described on page 2 of this instrument (the "Real Estate"), subject to those matters set forth and described on page 2 of this instrument (the Permitted Exceptions"). Grantor warrants to Grantee and to Grantee's successors in title that it has not created or permitted to be created any lien, charge, or encumbrance against the Real Estate that is not shown among the Permitted Exceptions; and Grantor covenants that it will defend said Real Estate to the extent of the warranties made herein against all persons lawfully claiming by, through or under Grantor, but not otherwise.

Grantor also hereby grants to Grantee, Grantee's successors and assigns, all rights and easements appurtenant to the above described Real Estate, the rights and easements for the benefit of said Real Estate set forth in the Declaration of Condominium, aforesaid, and Grantor reserves to itself, its successors and assigns the rights and easements set forth in said Declaration for the benefit of the remaining property described therein. This instrument is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

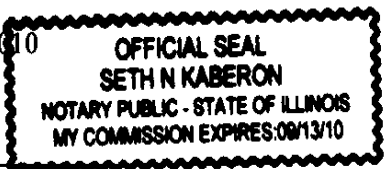
