7. Agreements About Miscellaneous Proceeds; Forfeiture. All Miscellaneous Proceeds are assigned to and will be paid to Lender.

If the Property is damaged, and subject to the rights of any Person with a superior Lien on the Property, the Lender will apply any Miscellaneous Proceeds to restore or repair the Property, if the restoration or repair is economically feasible and Lender's security given in this Security Instrument is not lessened. (b) Lender's Rights.
