- 1. Section 8.01 of ARTICLE VIII, and all references made thereto are hereby deleted in its entirety.
- 2. The Board consents to this First Amendment to the Declaration pursuant to the powers set forth in the Illinois Condominium Act and in ARTICLE V, <u>Administration</u>, Section 5.07 <u>General Powers of the Board</u>, Subsection (e) <u>Adopt Rules and Regulations</u>.
