### SUBCONTRACTOR'S CLAIM FOR MECHANICS LIEN

- Since on or about September 23, 2008, and subsequently, Khurram and Sameera Hussain have owned fee simple title to the Real Estate (including any and all improvements thereon) (the "Real Estate") in Cook County, Illinois, commonly known as 827 Taft Road, Hinsdale, IL 60521, and legally described as follows:
  - Lot 10, Lot 11, Lot 11A and Lot 12 in Block 5 in the Woodlands, Hinsdale, IL, being a Subdivision of the Southwest 1/4 of Section 7, Township 38 North, Range 12, East of the Third Principal Meridian, (excepting therefrom the West 1312.4 feet of the North 718.2 feet of said Southwest 1/4) in Cook County, Illinois.
- 2. On or about August 26, 2009, RESIDENTIAL STEEL FABRICATORS INC. entered into a subcontract agreement (the "Subcontract") with Orren Pickell Homes, LLC pursuant to which RESIDENTIAL STEEL FABRICATORS, INC. agreed to provide the labor, tools, materials, equipment and supervision necessary for the performance of installing structural steel for the improvement of the Real Estate (the "Work"), in exchange for payment of the original amount of One Hundred Sixty Nine Thousand Five Hundred Dollars (\$169,500.00), as more fully described in the Subcontract.
- 3. The Subcontract was entered into by Orren Pickell Homes, LLC and the Work was performed by RESIDENTIAL STEEL FABRICATORS, INC. with the knowledge and consent of Khurram and Sameera Hussain. Alternatively, Khurram and Sameera Hussain knowingly permitted RESIDENTIAL STEEL FABRICATORS, INC. to perform Work to improve the Real Estate.

- 5. The last date on which RESIDENTIAL STEEL FABRICATORS, INC. performed work required under the Subcontract was February 2, 2010.
- 6. As of the date hereof, there is due, unpaid and owing to RESIDENTIAL STEEL FABRICATORS, INC. therefor, after allowing all credits, the sum of Ninety One Thousand Four Hundred Sixty S.x Dollars (\$91,466.00) for which, with interest at the rate provided by 770 ILCS 60/0.01, RESIDENTIAL STEEL FABRICATORS, INC. claims a lien against the improvements, the Real Estate, and the monies or other consideration due or to become due to Orren Pickell Homes, LLC from Khurram and Sameera Flussain.
