EIGHTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP PURSUANT TO THE CONDOMINIUM PROPERTY ACT 550 ST. CLAIR CONDOMINIUMS

THIS EIGHTH AMENDMENT TO DECLARATION ("Amendment") is made and entered into by 550 St. Clair, Inc., an Illinois corporation, (hereinafter referred to as "Declarant");

WHEREAS, by that certain Declaration of Condominium Ownership on January 31, 2008, 550 St. Clair, Inc., an Illinois corporation, an Illinois corporation, executed the Declaration of Condominium for the 550 St. Clair Condominium and recorded on February 7, 2008, with the Cook County Recorder of Deeds, as Document Number 0803822033 (the "Declaration"), and amended by the First Amendment to the Declaration of Condominium Ownership recorded March 4, 2008 with the Recorder of Deeds as Document Number 0806415035, and amended by the Second Amendment recorded March 28, 2008 with the Recorder of Deeds as Document No. 0808822028, and amended by the Third Amendment recorded April 21, 2008 with the Recorder of Deeds as Document No. 0811222041, and amended by the Fourth Amendment recorded May 9, 2008 with the Recorder of Deeds as Document No. 0813016041, and the Fifth Amendment recorded April 21, 2009, with the Recorder of Deeds as Document No. 0911131031, the Sixth Amendment recorded May 26, 2009, with the Recorder of Deeds as Document No. 0914631029 and the Seventh Amendment recorded October 29, 2009 with the Recorder of Deeds as Document Number 0930231061 the Declarant submitted certain real estate legally described on Exhibit A attached hereto and made a part hereof the Condominium Property Act of the State of Illinois (the "Act"), and on said Condominium being known as the 550 St. Clair Condominium (the "Condominium");

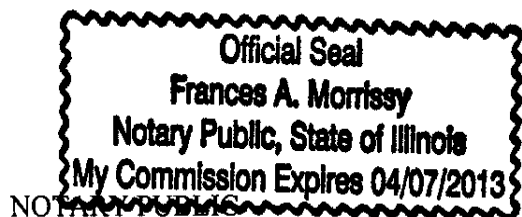
