735 ILCS 5/9/117 is not applicable to this order entered pursuant to Article 15 (IMFL).

That upon request by the successful bidder or its assigns and provided that all required payments have been made pursuant to 735 ILCS 5/15-1509, The Judicial Sales Corporation shall execute and deliver to the successful bidder or assignee a deed sufficient to convey title.

IT IS FURTHER ORDERED:

That the successful bidder is entitled to and shall have possession of the premises as of a date 30 days after entry of this Order, without further Order of Court, as provided in 735 ILCS 5-15-1701;

That the Sheriff of Cook County is directed to evict and dispossess Vitangi, Inc., Alpesh Patel, Suresh Patel and Jagruti Patel from the premises commonly known as 300 South Cicero Avenue, Chicago, Illinois 60644; and

IT IS FURTHER ORDERED that the Deed to be issued hereunder is a transaction that is exempt
