NOTICE OF LIEN FOR UNPAID COMMON CHARGES

To: The Recording Officer of Cook County, Illinois; Inna T. Flairty and David Flairty; and whom else it may concern:

Please take notice that the Sixty Thirty Condominium Association, an Illinois not-for-profit corporation, the undersigned Lienor, has and claims a lien for unpaid common elements charges pursuant to 765 Illinois Compiled Statutes 605/9, and pursuant to Article VI, Section 7 of the Bylaws of the Association, as follows:

1. The name of the lienor is the Sixty Thirty Condominium Association, acting on behalf of all unit owners of Sixty Thirty, a condominium association pursuant to a Declaration of Condominium, called the declaration and recorded in the Recorder's Office of Cook County, Illinois on June 28, 2002.
2. The names of the owners of the real property described below, against whose interest the lienor claims a lien, are Inna T. Flairty and David Flairty.
3. The property subject to the lien claimed is Permanent Tax Number 14-05-214-035-1159, commonly known as Unit 1404 in the Association, 6030 N. Sheridan Road, Chicago, Illinois, a condominium as delineated on Plat of Survey of the following described parcel of real estate:

4. As provided in the declaration, and in the bylaws, amounts assessed as common expenses remaining unpaid constitute a lien against the units with respect to which the assessment was made.
5. As recited in the deed to the unit, accepted by Inna T. Flairty and David Flairty as grantees, the unit is held subject to all the terms and conditions contained in the declaration and bylaws of the Association, including the condition that the proportionate share of common expenses stated above must be paid by the unit's owners.



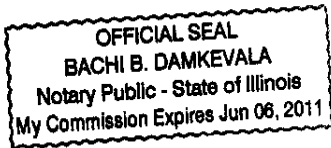
