The Lien Creditor, VILLAGE OF SKOKIE, an Illinois Municipal Corporation, pursuant to Section 2-1072 and 2-1078 of the Skokie Village Code and Section 1-2.1-8 of the Illinois Municipal Code, 65 ILCS 5/1-2.1-8, does hereby file a Notice of Lien in its favor in the amount of EIGHT THOUSAND THREE HUNDRED THIRTY DOLLARS (\$8,330.00), against all real and personal property owned by Michele Ranger, pursuant to Citations Numbers LO0004430, LO0008113, LO0008301, LO0008302, LO0008303, LO0008421, LO0008422, LO0008437, LO0008439, LO0011611, LO0011612, LO0011614, LO0011615, LO0012032, LO0012033, and LO0012036, including, but not limited to, the following described real estate:

On or about November 14, 2003, December 10, 2004, December 9, 2005, May 12, 2006, January 12, 2007, August 8, 2008, and May 8, 2009, respective to the above cited citations, an order was entered by the Village of Skokie Administrative Law Officer finding that Michele Ranger was in violation of the Skokie Village Code and issuing fines totaling SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500.00). On February 12, 2010, the Administrative Law Officer authorized this Lien for the amount of the above fines and the cost of enforcement of the order in the amount of EIGHT HUNDRED THIRTY DOLLARS (\$830.00) and the total amount of EIGHT THOUSAND THREE HUNDRED THIRTY DOLLARS (\$8,330.00) is now a charge against Michele Ranger.
