**THIS INDENTURE WITNESSETH**, That the Grantor/s, Nancy R. 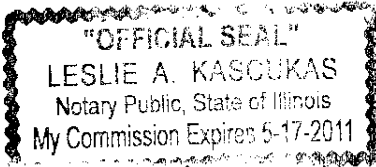

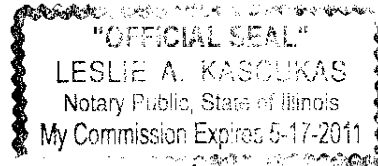

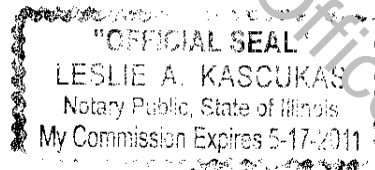
