4. Fire, Flood and Other Hazard Insurance. To this end the provisions of this Security Instrument and the Note are declared to be severable
 - 15. Borrower's Cory Borrower shall be given one conformed copy of the Note and of this Security Instrument.
- 16. Hazardous Substances. Borrower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property.
