THIS INDENTURE WITNESSETH, That the Grantor/s, **ROGER R. REICHARD and JEANETTE I. REICHARD, his wife,** and in consideration of Ten ----- (\$10.00)----- Dollars, and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 18th day of November, 2009 and known as Trust Number 1-8060, the following described real estate in the County of Cook and the State of Illinois to wit:

Any the said Grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.

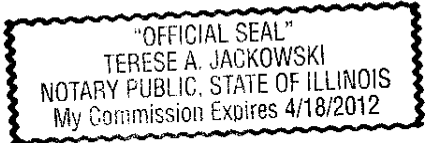

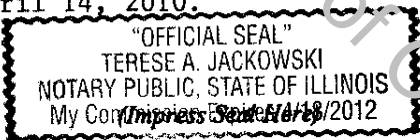

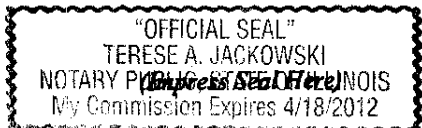
