requires in connection with a notice of transfer of servicing. 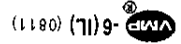

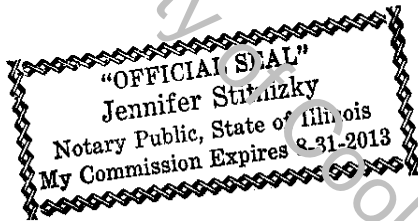
