As a result of participation in the Senior Citizens Real Estate Tax Deferral Program, the lien, number 95324768, was filed in the recorder of deeds' or registrar of titles' office in Cook County on May 18, 1995. 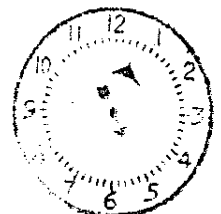
