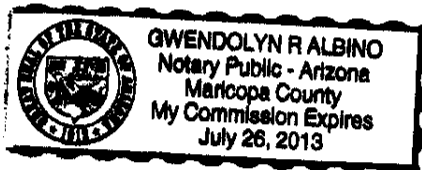

LEGAL DESCRIPTION
