
The following reservations from and exceptions to this conveyance and the warranty of title made herein shall apply.



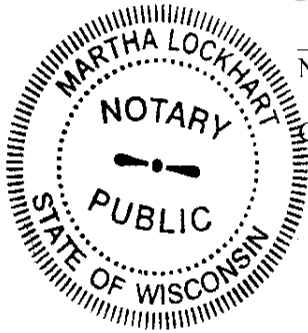
